Beschreibung	<p>The rise of BRICS (Brazil, Russia, India, China, and South Africa) has significantly impacted global politics, presenting both challenges and opportunities for the ‘emerging’ powers and the rest of the world. Comprising some of the largest and most populous countries, BRICS have frequently offered an alternative perspective on global governance issues and questioned the established features of the international order, thereby altering its dynamics. Along this path, BRICS has successfully attracted new and potential members and established new institutions and platforms for cooperation, such as the New Development Bank. Why did BRICS emerge as a grouping, and how has it evolved? What positions and preferences do BRICS countries hold on a global level regarding international institutions and forums such as the UN, the IMF, and the G20, as well as in various policy areas like security, trade, and the environment? What driving forces underpin these positions? What impact does the rise of BRICS have on the international system? In connection to these questions the seminar explores International Relations theories, including power-based (neorealism) and domestic politics (liberalism, societal approach) explanations, and provides an opportunity to learn how to apply theoretical knowledge to empirical case studies, offering a deeper understanding of the motivations behind the actors' positions.</p>
