International Organizations and Informal Clubs in Global Governance

Beschreibung
The seminar addresses the current challenges faced by international organizations (IOs) on various global issues. It provides students with an understanding of the main theoretical and empirical aspects of the role of IOs in international politics, including peace and security and the management of international economic relations, as well as the practice of international cooperation on various issues and at different levels. In this seminar, students will gain insights into (i) the changes and continuities in the roles and functions of formal IOs such as the United Nations and the Bretton Woods Institutions; (ii) the interaction between states and IOs and the consequences of variations in nation-state positions within these organizations for their effectiveness; and (iii) increasing informal governance through club networks such as the G20. The learning outcome is to provide in-depth theoretical knowledge of the main theories of international relations and international political economy and to apply these to empirical case studies, thereby providing students with insights into the international and domestic political forces that influence activities and effectiveness of IOs.
